It is to inform that **Two (02) posts** of Senior Superintendents are vacant in the Unit of West Godavari consequent to the promotion of Smt. T. Ananda Lakshmi, Senior Superintendent as Chief Administrative Officer and retirement of Sri N.N.V.S. Prasada Rao, Senior Superintendent, Principal District Court, Eluru on 31.08.2024.

As per the Rules in vogue the post of Senior Superintendent (Category-II) is a **selection post** by promotion of eligible employees from the post of Superintendents (Category-III). The candidates at the ratio of 1:3 for each post should be called for interview for selection to the post of Senior Superintendent.

As per A.P.J.M.S. Rules, 2019 vide G.O.Ms.No.76 Law (LAJ A & J Home Courts.D) Department, Dt.15.05.2019, the requisite qualification prescribed for holding the post of Senior Superintendent is **Must be a Graduate from any recognized University** and must have passed Departmental Tests of Accounts, Civil Judicial Test Parts I & II, Criminal Judicial Test I, II, III & IV and Translation.

In the recent paper promotions issued by this Court, Smt. T. Ananda Lakshmi, Senior Superintendent was promoted as Chief Administrative Officer. Thus, there arose one vacancy with effect from 27.04.2024 in the Senior Superintendent cadre. As this Office has not issued any notification for the said post, it is appropriate to forward the representation of Sri M. Umamaheswara Rao to Hon'ble High Court for instructions while keeping one vacant post for notification.

On that the Hon'ble High Court addressed a letter in ROC.No.957/2024-C-1, Dt.21.09.2024, stating that "Appointing Authority shall take appropriate decision on the representation of Sri M. Uma Maheswara Rao, Superintendent, in the light of the instructions in the Hon'ble High Court's Circular in ROC.No.1060/2022, Dt.18.10.2022, wherein it is specifically held that the relaxation was extended only for the posts carrying scale of pay less than that of a Junior Assistant and also instructed to follow the same "scrupulously".

In view of the directions of the Hon'ble High Court, the request of **Sri M. Umamaheswara Rao**, Superintendent, Additional Civil Judge's Court (Junior Division), Palakol, is "<u>rejected</u>".

As per Gradation List 2023, on the strength of seniority, the following members hereby listed for the promotion subject to meeting the conditions. vacancy position is two (2), the number of candidates to be empaneled is under 1:3 ratio.
