Sub: District Judiciary – Filing of Transfer Petitions on one of the grounds that connected suits are pending on similar jurisdiction Courts - Causing inconvenience in passing appropriate orders as the connected suits are varying in the year of institution – Circular Instructions issued – Despite of it receiving applications for transfer of cases from one court to another on the ground that though the parties are one and the same, matters have been posted to different courts – Cross check as to any connected suits are pending while numbering – Instructions – Issued.

This is to inform that, despite of the circular of the District Court dt.04.01.2023, the office has been receiving applications under section 24 of CPC for transfer of cases from one court to another simply on the ground that though the parties are one and the same, matters have been posted to different courts.

Hence, all the officers especially numbering Courts are hereby once again instructed to cross-check specifically any connected suits/cases are pending and as far as possible, the numbering court shall made over the newly filed case to the concerned court to avoid the complexities of filing applications under section 24 of CPC.

This shall be treated as important and all numbering court shall take steps accordingly.

Numbering court shall directed the concerned to verify in the CIS data as to any connected cases are pending. If connected case is pending in the respective courts of similar jurisdiction the numbering court may take steps to made over the same to the concerned Court.
