Adverting to the subject and reference cited, I am to inform that in the recent Coordination Committee meeting held at Bhimavaram on 26.10.2024, it is unanimously agreed that on fourth Saturday of every month, there would be a meeting between the Police Department and the Judiciary at the grassroots levels, that is, with respect to courts, from district court to magistrate court, for cross-checking the number of charge sheets that are pending or numbered or PRCs or warrants or summons to stop.

As agreed and as considered, I request you to instruct your concern to visit the respective courts and coordinate with our Judicial Department. These prototype efforts, in my view, would create a long-lasting coordination which affects an effective administration of the criminal justice system.
