Conditions:

1. These orders shall come into force with immediate effect.
2. The individual shall join duty **on or before 14.02.2025** and report before the Chairman-cum-Prl. District Judge/Chairperson, PLAPUS, DLSA, West Godavari, Eluru, otherwise his appointment will be cancelled.
3. The individual has to produce **Physical fitness certificate** issued by a competent Medical Officer not below the rank of Civil Assistant Surgeon at the time of his joining duty.
4. The appointment of the above individual is purely on temporary and contract basis as per Rule 9 of A.P. State and Subordinate Service Rules, 1996 and he is liable for termination at any time without assigning any reason or notice.
5. The above individual shall attend general duties as directed by the Chairman-cum-Prl. District Judge/ Chairperson, Permanent Lok Adalat for Public Utility Services (PLAPUS), DLSA., West Godavari, Eluru.
6. The individual is entitled for 15 days Casual Leaves per year.
7. The individual has to attend the duties promptly and maintain registers and records. If any deviation in attending the duties, the services of the individual will be terminated.
