I am to invite your kind attention to the reference cited and to inform that the Social Welfare (CV) Department have informed that Government have constituted One Man Commission and appointed Sri Rajiv Ranjan Mishra, IAS(Retd.) as Chairman, OMC to suggest specific recommendations on sub-classification of SCs in the State of Andhra Pradesh.

2. They have further informed that the Chairman, OMC has informed that, certain categories of posts were not covered in the sub-caste-wise data of employees belonging to Scheduled Castes working in various

categories across all Government departments in the State, as furnished by the Departments concerned. Further, the information submitted for the five-year period does not meet the requirements of the Commission. Additionally, there is a lack of consistency and equity in the submitted data, making it exceedingly difficult to compile and analyze the information effectively.

- 3. The Social Welfare (CV) Department have therefore requested to submit sub-caste wise details of Scheduled Caste (SC) employees in the prescribed proforma for the last ten years (year-wise separately), along with a consolidated report in Excel format duly counter signed by the authenticated officer concerned through mail (Id:omcscsubclassification@gmail.com) by 20.01.2025.
- 4. I, therefore, request you to examine into the matter and furnish the requisite information in the prescribed proforma, to Government immediately for taking further action.
