In the light of the directions of the hon'ble High Court of Andhra Pradesh in the reference 2nd cited above, the undersigned is pleased to pass the following instructions to all the Nodal Officers and Judicial Officers in the District Judiciary, West Godavari.

All the Nodal Officers working in the unit of the West Godavari are directed to take immediate steps for maintaining e-Waste collection kiosks in their respective Court Complexes on 19-04-2024 and take immediate steps for disposal of e-Waste as per E-Waste (Management) Rules, 2022 and its subsequent amendments made by the Government of India from time to time for the unserviceable computer hardware and peripherals provided or purchased prior to the year 2017 as per the Hon'ble High Court's letter 2nd cited above and submit report to the undersigned for taking further action in this matter.

All the Judicial Officers working in the unit of the West Godavari are directed to take immediate steps for sending unserviceable computer hardware and peripherals duly listing the same in the enclosed proforma provided or purchased prior to the year 2017 to the e-Waste collection kiosks of their respective Court complexes.

The Chief Administrative Officers/ Senior Superintendents/ Superintendents of higher Courts of their respective Court Complexes are directed to organize an e-waste collection kiosk in their Court Complexes without delay, and submit report to their Nodal Officers.

This may be treated as most important and urgent.
