The Ld. Member Secretary, H.P. State Legal Services Authority, Shimla vide its letter No.12/LSA/NLA/SC/2025/-38-42, Dated 03.01.2025, has informed that **First** National Lok Adalat of this year is going to be held on **8**th **March, 2025** and thus, this is the right time to synergize out energy and efforts at the beginning to achieve better results as no much time is left for the upcoming National Lok Adalat. The following guidelines are being issued for preparation:-

1. Emphasis be laid on identification of Motor Vehicle Challan Cases, Criminal Compoundable Cases, both at Pre-Litigation and Post-Litigation stage including Excise Compoundable Cases and Petty Offences.

2. For pending Motor Vehicle Challan Cases in the Courts, facility i.e., ePay (eCourt Digital Payment) for online payment of compounding fee/fine be used for

maximum disposal.

3. Effective identification of Motor Accident Claims, Insurance matters, Matrimonial Disputes, Land Acquisition Matters, Civil Disputes and cases under Negotiable Instruments Act, etc., be made.

4. Best efforts be taken to identify cases at Pre-Litigation stage by holding regular meetings with banks, financial institutions, stakeholders and insurance

company, etc.

- 5. Effective coordination be made with process serving agencies working under HP Police to expedite the service of summons issued to the parties for National Lok Adalat.
- 6. In order to avoid large footfall on the day of National lok Adalat (8th March, 2025), Pre-Lok Adalat conciliation sittings for court based matters (Challan Cases, Petty Offences and other matter(s)) be held at District and Sub Division level on weekly basis by fixing date(s) after coordinating with HP Police and Transport Department, so that required number of compounding officers from HP Police and Transport Department join the proceedings.

7. Wide publicity about the upcoming National Lok Adalat be given in print and

electronic media.

8. Presiding Officers, Family Courts and Industrial Tribunal-cum-Labour Courts to identify maximum number of cases for this upcoming National Lok Adalat.

9. Regular Meetings be held by Chairmen DLSAs, Chairmen SDLSCs and Secretaries DLSAs, with Bar Association, Stakeholders, Financial Bank Institutions, Insurance Companies, etc.

Further, it is requested to hold the National Lok Adalat as per schedule and send the list of cases identified for first National Lok Adalat scheduled to be held on 8th March, 2025 be submitted to this Authority, as per following schedule/dates:-
