Qualification

Any teacher (including retired teacher), Retired Government Servants and Senior Citizens, Master of Social Welfare Students and Teachers, Anganwadi workers, Doctors/Physicians, Students and Law Students (till they enroll as lawyers), Members of Non-Political service oriented NGOs and Club, Members of Women Neighborhood Groups, Maithri Sangathans and other Self Help Groups including marginalized/vulnerable groups may apply.

Applicant should be literate, preferably matriculate with a capacity of overall comprehension. The preference shall be given to applicants who do not look up to the income they derive from services as PLVs, but should have a mind set to assist the needy.

NOTE: The work of PLVs (Adhikar Mitra) does not carry any salary, remuneration or wages except honorarium Rs. 400/- per day fixed by the Punjab State Legal Services Authority, SAS Nagar and no application will be received after 23.05.2025 District Legal Services Authority, Barnala will not be responsible for any postal delay.
