The District Judges are requested to follow the steps detailed below in this regard.

i) Appoint the System Assistants allotted in the respective Districts by executing the agreement (draft agreement appended). The Original ID proof and the Medical Certificate produced by the Appointee be verified.

ii) The date of completion of 2 years be shown as the the date of termination in the agreement, in respect of the appointees joining prior to/or on 31.08.2023. In respect of appointees joining after 31.08.2023 , the date of termination be shown as 31.08.2025.

iii) A copy of the Original ID Proof, Educational Qualification Certificates shall be maintained in the Establishment branch/section of the District Court concerned. The appointees be directed to open a bank account and to furnish the details of same to the District Court.

iv) The names of Appointees who have not joined within the prescribed period of 10 days shall be reported to the High Court.

v)The service of the currently working System Assistants/System Officer shall be terminated w.e.f the AN of the date on which the newly recruited System Assistant report for duty. The newly recruited System Assistant shall be inducted into the service

on the very next working day to the date of reporting.

vi) M/s IHRD shall be intimated about the termination of the service of currently working System Assistants/System Officer as mentioned in clause (v) above, through email, on the date of termination itself. A copy of the same shall be furnished to the eCourt Cell.

vii) The System Assistants shall be deployed preferably in the ratio of 1 System Assistant for every 6 Courts. However the ratio may be varied based on the traffic and for ensuring smooth conduct of the eCourt project and court proceedings.

viii) Any act of disobedience/derelection of duty on the part of the System Assistants shall be reported to the High Court forthwith.

ix) Adequate training in eCourt Project with CIS and other eCourt Services, shall be imparted to the new recruits, in coordination with DSAs & ZO's of the District.
