Their appointment will be subject to the following conditions:

a) Their conditions of service shall be governed by the Kerala Judicial Service Rules, 1991 and other relevant rules in force;

b) They shall be on probation for a period of two years on duty within a continuous period of three years, from the date on which they join duty;

c) They shall also pass the Account Test for Executive Officers or the Account Test (Lower) and also pass such other tests as prescribed by the Rules within their period of probation;

d) On their joining duty, they shall produce before the District and Sessions Judge/ Chief Judicial Magistrate, a Certificate of fitness from a medical Officer not below the rank of a Civil Surgeon in the form prescribed in Rule 13 part I, Kerala Service Rules.

The Officers shall take charge in their respective stations on 20.02.2024. The Officers are not eligible for joining time or transfer grant.

The postings of the above officers are purely temporary subject to the General Transfers 2024 and promotion of Judicial Officers in the District Judiciary.

The Officers at Sl. No. 8,11,13,15,31 & 33 are eligible for Special Pay for extra administrative work @ ₹1250 /- per month in their new posts.

The Officers are eligible for Robe allowance @ ₹6000/-, once in three years as per the Government order read (4) above.

The Officers at Sl. Nos. 4,5,9,10,12,13,20,21,24,26,29,30,34,35 are eligible for the benefit of three advance increments as per the Government order read (4) above for possessing Post Graduate Degree in Law (LL.M.), at the time of their joining the Kerala Judicial Service.

The Accountant General will issue necessary authorisation for the drawal of pay/allowances to the aforesaid Officers, as sanctioned.

If any Officer mentioned in Column No. IV of the above Table happens to be absent on the date of his/ her taking charge, the Officer at Column No. II may take charge from the Officer who has been placed in full additional charge of such Officer.
