District Judiciary – Promotion, Transfer, Posting & filling up of vacancies of Sheristadars in the Gazetted Cadre of the District Judiciary - Orders issued

Read : Rule 31 of the Kerala State and Subordinate Services Rules, 1958

ORDER NO. HCKL/43/2024-B1(B)(II)

(I) As part of filling up the vacancies consequent to the Leave Preparatory to Retirement (LPR) availed by Sri. Vasudevan Pillai and Sri. M.G. Rajesh, Sheristadars of the District Judiciary, the following Officers, in the scale of pay of ₹ 56,500 – 1,18,100/- are posted as Sheristadar of District Court/STAT, in the scale of pay of ₹ 59,300 – 1,20,900/- in the stations mentioned against their names:
