Sri Arun Chandran M, Clerk, Munsiff Court, Taliparamba has to be reverted as Clerk with effect from 18-12-2023. As the vacancy of

Senior Clerk arose on 18-12-2023, Smt. Sneha P, Clerk has to be promoted as Senior Clerk on that date. The next vacancy of Senior Clerk arose on 01-01-2024 and Smt. Nisha N. K, Clerk has to be promoted as Senior Clerk on that date. On 10-01-2024, consequent to the promotion of Smt. Sheeja K, as Bench Clerk Gr.II, vacancy of Senior Clerk arose and Sri Arun Chandran who has been reverted as Clerk, has to be promoted as Senior Clerk on that date..
