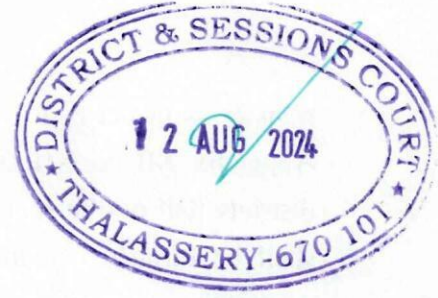

**OFFICIAL MEMORANDUM**

Sub:- Inter District/ Departmental/ Unit transfer to the post of Clerk in the Civil Judicial Unit of Pathanamthitta District - Applications invited for-Reg.

The undermentioned officers are informed that the District Judge, Pathanamthitta as per the letter cited 1<sup>st</sup> has reported one vacancy of Clerk in the respective district to be filled up by way of Inter district/departmental transfer. They are, therefore, requested to bring the matter to the notice of the employees working under their administrative control and to obtain and forward the applications for transfer to the Civil Judicial Unit of Pathanamthitta District from candidates who are eligible to apply for the same in the light of the Government Order cited 3<sup>rd</sup>.

**The District Judges and Chief Judicial Magistrates shall invariably verify and certify the correctness of the service particulars submitted in the applications especially with regard to the date of appointment as Clerk and actual qualifying period of service as Clerk in the District.**

The following instructions shall be followed while submitting/ forwarding the applications:

1. The applicants shall express their willingness (duly countersigned) to abide by the terms and conditions of the G.O. cited 2<sup>nd</sup> in the event of their transfer.
2. The applicants shall furnish a declaration to the effect that they agree to become the junior to the junior most in the post of Clerk in the event of their transfer, duly countersigned by the Appointing Authorities concerned.
3. The applicants should have completed the qualifying service for seeking inter district

transfer as prescribed in para 4(i) of the G.O. cited 3<sup>rd</sup>. The period of leave under Appendix XII A/ XII B/ XII C, Part I, KSRs and period of deputation in other districts will not be reckoned as service for the purpose. The details in this respect shall be furnished in the proforma enclosed herewith, duly countersigned by the Appointing Authorities.

4. The applicants seeking transfer on medical grounds of themselves/ their family shall produce the medical certificate (duly countersigned) in support of the request.

**Applications received otherwise will not be considered.**

5. In the case of dependents/ near relatives of serving soldiers, the soldier should send the application for transfer of the dependents/ near relative through their military authorities. **Applications received otherwise will not be considered.** Only one dependent/ near relative of a soldier will be given preferential treatment in the matter of transfer.
6. The applicants holding post of Senior Clerk shall furnish a representation addressed to the Government for reversion to the entry cadre with a specific report of the Appointing Authority concerned as mentioned in the High Court O.M. cited 4<sup>th</sup>.
7. Subsequent request for cancellation of the sanctioned transfer shall not be entertained except under compelling circumstances.
8. Applications received at the High Court prior to the date of this O. M. will not be considered. **Last date for receiving application at the High Court is 24/08/2024.**

**Applications that do not adhere to the prescribed format attached along with this official memorandum, contain false or incomplete details, or are received after 24/08/2024 at the High Court will not be considered.**
