As part of filling up the existing vacancy of Clerk the following promotion, appointment, transfer and postings are ordered.

- 1. Smt.Jisha Brijith .P (PEN:639294), Amin,District Court, Kasaragod, in the scale of pay (₹25100 ₹57900/-) is temporarily promoted as Clerk in the scale of pay (₹26500 ₹60700/-) subject to the conclusion of vigilance proceedings pending against Sri. Anandakrishnan. T, Amin, District Court, Kasaragod. She is transferred and posted as such in the Munsiff's Court, Kasaragod in the existing vacancy.
- 2. Smt.Sheeba.C.M.(PEN:636590), Attender Gr-I, Sub Court, Kasaragod in the scale of pay (₹24400- ₹55200/-)is promoted as Amin in the scale of pay (₹25100 ₹57900/-). She is transferred and posted as such in the District Court, Kasaragod, vice,Smt.Jisha Brijith.P.

As per O.M No. HCKL/1123/2024-C1-HC KERALA dated 06.08.2024 directions has been issued to regularize promotion granted without declaration of probation in the feeder category post from 01.01.1998. Hence, this Court has revised date of appointment as Attender Gr- II and further promotion as Attender Gr- I and Amin of the employees worked/ working in this department from 01.01.1998 onwards and published a draft list. The draft list has been submitted to the Hon'ble High Court of Kerala and sought clarification regarding the implementation of the revised pay fixation as per the published draft. Therefore, the above promotion , appointment by transfer will be subject to the clarification received from the Honble High Court.

The Hon'ble High Court of Kerala as per O.M No. HCKL/2240/2024-C1-HC KERALA dated 17.08.2024 has directed to defer the filling up the vacancies in the post of Process Server until further orders. There fore the resultant vacancy of Process Server is kept unfilled for the time being.
