4. The Presiding Officers are further requested to see that the draft list has been shown to each and every **Process Server** working in their respective offices and an acknowledgment obtained from them in this regard.

5. The Presiding Officers are also requested to furnish a 'NIL' report if none of the **Process Server** working in their respective courts has objections.

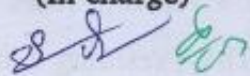

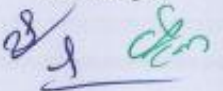
