3. The Presiding Officers will further verify the draft list with respect to the service register of the incumbent concerned and will send a report to this office along with the available data, if they find any omissions or if corrections are necessary in the draft list.
4. The Presiding Officers are further requested to see that the draft list has been shown to each and every **Amins** working in their respective offices and an acknowledgment obtained from them in this regard.

5. The Presiding Officers are also requested to furnish a 'NIL' report if none of the **Amins** working in their respective courts has objections.
