2. The Presiding Officers will forward the objections received by them to this office immediately after the expiry of the time prescribed. Before that they will go through each of the objection and offer their specific remarks on them and certify the correctness of the facts mentioned therein.
3. The Presiding Officers will further verify the draft list with respect to the service register of the incumbents concerned and will send a report to this office along with the available data, if they find any omissions or if corrections are necessary in the draft list. Additions if any, towards general or special qualifications of the candidates may also be specified.
4. The Presiding Officers are further requested to see that the draft list has been shown to each and every Bench Clerk Gr.I/Central Nazir/Head Clerk and Bench Clerk Gr.II working in their respective offices and an acknowledgment obtained from them in this regard.
5. Objections previously considered will not be entertained again.
6. The Presiding Officers are also requested to furnish a 'NIE report if none of the Bench Clerk Gr.I/Central Nazir/Head Clerk and Bench Clerk Gr.II working in their respective courts has objections.
