Civil Judicial Department – Establishment – Renaming of 'Medicare Cell" constituted in the Pathanamthitta District for the expeditious disbursement of Medical Reimbursement to the Retired Judicial Officers and expanding the functioning of Medicare Cell - Orders issued.

ORDER No.JS-I- 2888/2023

As per the direction of the Hon'ble High Court vide Official Memorandum read 1st above, Medicare Cell has been constituted in this District vide order read 2nd. In addition to the assistance provided to the retired Judicial Officers in getting timely reimbursement of their Medical Claims, the Hon'ble High Court of Kerala, vide Official Memorandum read 3rd cited, has directed to provide adequate support to Judicial Pensioners to process their claims for arrears of various allowances not included in the revised pay slip, by renaming the cell as 'Medicare & Facilitation Centre' and also by deputing more staff if necessary.

In view of the above directions, Medicare cell constituted in the Pathanamthitta District is renamed as **Medicare & Facilitation Centre**.

- If the retired Judicial Officers request for assistance to prepare claim form of reimbursement or for collecting the form or bills from their residence, the centre shall provide such help through the Nazerette concerned without incurring additional expenditure.
- The centre shall provide adequate support to Judicial Pensioners to process their claims for arrears of various allowances not included in the revised pay slip.
