Sl.No.2 to 11 will be on probation for a total period of 1 year within a continuous period of 2 years as per Rule 14(ii) of the Kerala Judicial Ministerial Subordinate Service Rules and Rule 9(ii) of the Kerla Last Grade Services.

The fixation of pay of the promotees will be in accordance with the provisions contained in Para 40 of the G.O read 2nd above.

The travelling allowance in respect of transferees will be determined in accordance with para 46(d) of GO(P) No.480/89 Fin. dated 11.01.1989.

The Joining time in respect of Sl.No.1, 2, 3, 6, 10, 11 and 12 are restricted to 2 days.

The incumbents will be relieved forthwith. The Presiding Officers concerned shall report to this office the date of relieving and joining duty of the incumbents in the respective offices.
