# DISTRICT COURT, KOTTAYAM TENDER NOTICE

Sub:- Annual Maintenance Contract for maintenance of various types of UPS' installed in the Subordinate Courts in the Kottayam Judicial District – Inviting tenders.

Limited Tenders in sealed covers are invited from the reputed firms, dealing with the maintenance of computers and accessories, for the maintenance and supply & replacement of batteries under buy back scheme for various types of UPS' and power capacities (specified in Annexure-I) installed in the Subordinate Courts in the Kottayam Judicial District (locations specified in Annexure-II).

In the tender forms, the firms shall clearly specify the rates, terms and conditions etc. Further details if any can be obtained from the office of the District Court, Kottayam on all working days between 10 A.M. and 5 P.M.

The tenders should be superscribed with "TENDER FOR ANNUAL MAINTENANCE CONTRACT OF UPS' FOR KOTTAYAM JUDICIAL DISTRICT".

The sealed tenders must be addressed to the District Judge, District Court, Collectorate P.O., Kottayam - 686 002.

The bidders are required to deposit 1% of the estimated amount as earnest money deposit (EMD) subject to a **minimum of Rs.2200/-** for taking part in the tender. The sealed tender forms received within the stipulated time will be opened by the District Judge, Kottayam by fixing a date, later on.

#### Last date fixed for submitting Tender: 27.07.2023 at 4.30 p.m.

Late tender forms in no case will be accepted and sealed tenders received within the stipulated time will be opened by the District Judge, Kottayam and the acceptance of tender will be strictly in accordance to the provisions in the Store Purchase Manual 2013.

The accepted tender will be sent to the Hon'ble High Court of Kerala for sanction. Thereafter, the successful tenderer shall enter into an agreement with the District Court, Kottayam regarding the service, terms and conditions for the Maintenance of the computers.

The successful bidder is also required to furnish the performance security equivalent to 5% of the total value of the quoted rate which must be paid in the form of Demand Draft/Fixed Deposit Receipt or Bank Guarantee in favour of District Judge, District Court, Kottayam which have a validity for a period of 60 days beyond the completion of the contract date. The EMD of the successful tenderer will be returned thereafter.
