ORDER NO. E- 6624/2023 DATED 09.11.2023

As per the reference Ist cited above Sri. Soju. P.Markose, Junior Superintendent(on leave) Judicial First Class Magistrate Court-I, Changanacherry has been granted extension of Leave Without Allowance for a period of 3 years w.e.f. 16.11.2020 in continuation of the leave sanctioned to him to join spouse abroad as per the order read as 2nd above.
