**ORDER No. E- 7822/23 DATED 13.12.2023**

As per the advice list received from the District Office, Kerala Public Service Commission, Kottayam, the following appointment and posting of L.D Clerk is ordered to take effect immediately.

Smt. Lethika G, Udumbachel, Elamgulam, Kottayam, 686506 is temporarily appointed as L.D.Clerk in the Scale of Pay of ₹26500- 60700 and posted in the Court of Judicial First Class Magistrate-I, Kanjirappally in the existing vacancy. The appointee is directed to appear before the Judicial First Class Magistrate-I, Kanjirappally for joining duty on the F.N. of 13.12.2023.

The appointment is purely temporary under Clause (1) of Sub Rule (a) of Rule 9 of the General Rules as provided in Rule 10 (b) of these rules (Vide G.O (P) No. 49/74/PD) dated 05.03.1974 subject to the Rule 3 (c) of General Rules of Kerala State and Subordinate Service Rules 1958. The candidate is informed that her appointment shall be terminated without notice if Government is not satisfied of her character and antecedents.

The Government Orders regarding the National Pension System (NPS) is applicable to the incumbent. She will submit the duly filled up application form in duplicate (copy attached) at the time of joining duty. The section concerned will take for the allotment of Permanent Retirement Account Number (PRAN) to the incumbent following the procedure laid down in the Government Orders.

Further the candidate is informed that in the event of discharge from service for want of vacancy, she may either re-register her name in the Office of the Public Service Commission from where she was advised and got herself re-appointed on further advise by the Public Service Commission or she may wait for her turn

for re-appointment to the post in the Department, in case she desires to continue as probationer in the post from which she was discharged (Vide Govt., Circular No. 3737/Rules -1/90/P & ARD dated 12.02.1991)

The appointee will produce the proforma attached duly filled up and signed, when she reports for duty.

The appointee is directed to report duty before the Judicial First Class Magistrate-I, Kanjirappally on 13.12.2023 F.N, failing which the appointment shall be cancelled without any further notice.

The Judicial First Class Magistrate-I, Kanjirappally shall admit the candidate for duty after administering the oath of allegiance and satisfying the identity of the candidate. The Magistrate shall obtain and forward the prescribed proforma duly filled up by the candidate.
