As per the advice list received from the District Office, Kerala Public Service Commission, Kottayam, the following appointment and posting of L.D Clerk is ordered to take effect immediately.

Vishnu Mohan, Sreevinayaka, Malayil, Veliyam P O, Kollam, PIN:691540 is temporarily appointed as L.D.Clerk in the Scale of Pay of ₹26500- 60700 and posted in the Court of Judicial First Class Magistrate-II, Kottayam in the existing vacancy. The appointee is directed to appear before the Judicial First Class Magistrate-II, Kottayam for joining duty on the F.N. of 12.02.2024.
