As per the G.O referred as 2nd above, sanction was accorded for the appointment of Sri. Anish Kumar R, Unmarried Brother of Late. Aswathy R, former Process Server, District Court, Thodupuzna as Clerk in the Civil Judicial Unit Kottayam, in the quota reserved for employment under Compassionate Employment Scheme of the dependents of Government servants who die in harness, adhering to the terms and conditions specified in the G.O referred as 2nd above.

Accordingly, Sri. Anish Kumar R, Unmarried Brother of Late. Aswathy R, former Process Server, District Court, Thodupuzha is appointed as Clerk in the Civil Judicial Unit Kottayam, in the scale of pay ₹ 26500-60700, temporarily, under Rule 9 of the General Rules as provided for in Rule 10(b) of the Kerala State & Subordinate Service Rules 1958, and is posted in the office noted against his name as detailed below.

The candidate has personally appeared before me, and produced copy of application with his signature, residence certificate specifying the address, copy of Aadhar Card, original medical certificate, conduct certificates (2 Nos.), and attested passport size photograph (2 Nos.) of the incumbent.

The candidate is directed to join duty within 15 days on receipt of this order and shall produce the following documents (in original) at the time of joining duty.

1. Certificate showing Date of birth and qualification for the post of L.D Clerk.
2. Proforma, Statement of properties and Spark Form No.1 (Enclosed with this order) duly filled up and signed by the candidate.
3. Consent statement as per G.O(P) No. 12/2023/P&ARD dated 14.07.2023.

The Presiding Officer concerned shall verify the documents mentioned above and satisfy the correctness of the particulars before the candidate is admitted to duty. If there is any discrepancy, the candidate should not be allowed to join duty and the fact should be reported to this office forthwith. Once the candidate is allowed to join duty, a copy of G.O read as 2nd above attached herewith, shall be pasted in the Service Book. On joining duty the candidate shall take Oath of allegiance as per High Court Circular No. 18/64 and get the form duly signed to paste it in the Service Book.

The date of joining duty should be reported to this office immediately after joining duty of the candidate. In case the candidate does not join duty within the joining time allowed in the appointment order, report the matter to this office promptly.

As per the G.O read as 4th the State Government have implemented the National Pension System in this State for all appointments made on or after 01.04.2013. The appointment of the candidate will be in the contributing pension scheme and shall be on probation for a period of 2 years within a continuous service of 3 years.
