Sri. Babu Mathew, L.D Clerk, District Court, Kottayam, who was on LWA, since 01.07.2004 to 30.03.2023, vide orders read as 1st to 4th references, under Appendix XII A, Part I, K.S.R has put his resignation from the post of L.D Clerk vide letter read as 5th above.

The period of LWA of Sri. Babu Mathew expired on 20.03.2024 and he has intimated vide reference 5th above that he is unable to rejoin duty.

Hence, as per clauses (a), (b) and (c) of Government Decision No.1 under Rule 23, Part I, KSR, the resignation put in by Sri.
