As per the advice list received from the District Office, Kerala Public Service Commission, Kottayam, the following appointment and posting of L.D Clerk is ordered to take effect immediately.

Sri. Tenil Raju Daniel, Valiplackal House, Chittar, Pathanamthitta is temporarily appointed as L.D.Clerk in the Scale of Pay of ₹26500- 60700 and posted in the Court of Judicial First Class Magistrate-I, Ettumanoor in the existing vacancy. The appointee is directed to appear before the Judicial First Class Magistrate-I, Ettumanoor for joining duty on the F.N. of 25.03.2024.

The appointment is purely temporary under Clause (1) of Sub Rule (a) of Rule 9 of the General Rules as provided in Rule 10 (b) of these rules (Vide G.O (P) No. 49/74/PD) dated 05.03.1974 subject to the Rule 3 (c) of General Rules of Kerala State and Subordinate Service Rules 1958. The appointee is directed to report duty before the Judicial First Class Magistrate-I, Ettumanoor on 25.03.2024 F.N, failing which the appointment shall be cancelled without any further notice.

The Judicial First Class Magistrate-I, Ettumanoor shall admit the candidate for duty after administering the oath of allegiance and satisfying the identity of the candidate. The Magistrate shall obtain and forward the prescribed proforma duly filled up by the candidate.
