The appointment is purely on contract basis and will be terminated on completion of 179 days from 17.07.2024 or on completion of 62 years, whichever is earlier, as per direction under reference 4<sup>th</sup> cited above, with a consolidated pay of ₹ 18390/-, as per G.O. (P) No. 29/2021/Fin. Dated 11.02.2021. An agreement shall be executed between the District Judge for and on behalf of the Governor and the appointee.
