### Terms and conditions

(i) The appointment of above candidates as Offg. Stenographer Grade-III are purely on temporary basis and their services can be dispensed with at any time without any notice and assigning any reason therefor. They should give written undertaking in that behalf in the prescribed form before joining their duties.

(ii) That they should produce Medical fitness certificate from the Civil Surgeon, Amravati within a period of six months, as required by rule 11 of the Maharashtra Civil Services (General Conditions of Services) Rules, 1981. The accompanied form of "Candidates Statement and Declaration" should be filled up and signed by the candidates and produce it in the office at the time of joining.

(iii) The appointment of the above candidates is purely on temporarily basis subject to the conditions of report of verification of their Character and Antecedents from the Police Department. The accompanied " Attestation Form" should be filled up and signed by the candidates and it should be produced in the office at the time of joining.

(iv) That they swear on Oath of allegiance to the Constitution of India as by law established before joining their duties.

(v) In case they desire to resign, they are required to give one month's notice or to forfeit one months pay to the Government as per Government orders.

(vi) The candidates are directed to submit their Identity Proof ( Pan Card, Driving Licence, Aadhar Card....etc) at the time of joining. They are also directed to produce their original certificate of educational qualification at the time of joining. It will be returned after its verification.

(vii) The appointment of following candidates purely on ad-hoc basis is subject to conditions that, they will have to pass the requisite test/s as shown against their names within a period of one

year from the date of their respective appointment. They will be discharged from service if they do not secure the requisite bench mark of 35% marks for General Category and 30 % marks for Reserved Category, in requisite test/s, within aforesaid period of one year.
