Consequent upon the directions contained in the Hon'ble High Court letter referred at (2) above and in view of Select List prepared by the Recruitment Committee, District Court, Amravati for the post of Peon and approved by the Hon'ble High Court, Bombay, the Principal District and Sessions Judge, Amravati is pleased to pass the following order of appointment of candidate from the Select List in order to fill up the vacancy on the establishment of Family Court, Amravati, as under:-

1. The following candidate selected at **Sr. No. 21** of the Select List of Peon is hereby appointed temporarily as Offg. Peon in the Pay Matrix S:1 (Rs.15000 – Rs.47600) with usual allowances and posted as shown against his name.

#### Terms and Conditions

- (i) The appointment of above candidate as Offg. Peon is purely on temporary basis and his services can be dispensed with at any time without any notice and assigning any reason therefor. He should give written undertaking in that behalf in the prescribed form before joining his duties.
- (ii) That he should produce Medical Fitness Certificate from the Civil Surgeon, Amravati within a period of six months, as required by Rule 11 of the Maharashtra Civil Services (General Conditions of Services) Rules, 1981. The accompanied form of "Candidates Statement and Declaration" should be filled up and signed by the candidate and produce it in the office at the time of joining.
- (iii) The appointment of the above candidate is purely on temporarily basis subject to the conditions of report of verification of his Character and Antecedents from the Police Department. The accompanied "Attestation Form" should be filled up and signed by the candidate and it should be produced in the office at the time of joining.
- **(iv)** That he swear on Oath of allegiance to the Constitution of India as by law established before joining his duties.
- **(v)** In case he desire to resign, he is required to give one month's notice or to forfeit one month's pay to the Government as per Government orders.
- (vi) The candidate is directed to submit his Identity Proof (Pan Card, Driving License, Aadhar Card., etc.) at the time of joining. He is also directed to produce his original certificate of educational qualification at the time of joining. It will be returned after its verification.
- **(vii)** The concerned Head of Office is hereby directed to obtain the Oath and Undertaking of the newly appointed candidate, immediately

on his joining and its one copy be forwarded to this office, for record and one copy should be kept with his Original Service Book.

(viii) The newly appointed candidate is hereby directed to join his posting on 27/01/2025 B.N. without fail. If he failed to join his duties, his appointment will be treated as cancelled and his name will be deleted from the select list.
