Subject:- Uploading of daily orders/judgments on NJDG - Hiding parties name.

Ref:- This Court's letter No. 254-Spl./CB2 dated 27.02.2013 & email dated 17.07.2013 alongwith letter from Hon'ble eCommittee, Supreme Court of India.

Sir,
I am directed to refer you on the subject cited above and to inform you that in CIS Version 1.1 and 2.0 option is available to hide parties name, which will show "XXXXX" instead of parties name in the cases as mentioned in abovesaid letter. Same can be hidden either at the time of registration or thereafter by court staff/CIS user. Procedure for the same is annexed herewith as Annexure A & B.

I am further to inform you that after hiding the parties name, Court staff/CIS user can see the Names of the Parties in all other modules except in the Cause List, Query and Judgment/ order template. If Daily orders/judgments (in PDF format) are uploaded, same are accessible to all on National Judicial Data Grid alongwith parties name. No option is available to hide parties name in aforesaid daily orders/judgments. However, if daily orders/judgments are generated using templates provided in CIS 1.1 & 2.0 name of parties can be substituted by 'XXXXX'.

Matter regarding uploading of judgments on the CIS was already considered by the Hon'ble Executive Committee in its meeting held on 21.02.2013 and after due deliberations and consideration, Hon'ble Executive Committee was pleased to recommend as under:-

"Till such time, a final policy decision is taken, the judgments in cases of offences against women, juveniles and all other cases in which the Presiding Officers specifically so orders, be not uploaded."

Aforesaid decision was already conveyed to you, vide this Court's letter No. 254-Spl./CB2 dated 27.02.2013 (Copy enclosed).



(Management & Human Resources) has requested this Court not to upload case related information of cases relating to matrimonial matters (Family Courts), Juvenile Justice Act, Official Secrets Act, matters relating to Intelligence Agencies, matters relating to domestic violence and sexual offences against women & children etc. Aforesaid letter was also communicated to you vide this Court's email dated 17.07.2013.

You are, therefore, requested to direct the concerned official(s) to-upload all the daily orders/Judgments on National Judicial Data Grid except the cases mentioned in the aforesaid letters and hide parties name in CIS module, only in the cases mentioned in the letter under reference, so that the same are not visible to general public on National Judicial Data Grid.



Dear CPC,

With reference to the subject and referred letter given above, the undersigned is directed to reiterate that, the activity of uploading the case data for the ecourtindia portal is supposed to be a **daily routine**. It is therefore requested to give top priority to this updation of data on daily basis so as to avoid outdated information on ecourtindia portal.

It is further requested not to upload case related information of cases relating to matrimonial matters (Family Courts), Juvenile Justice Act, Official Secrets Act, matters relating to Intelligence Agencies, matters relating to domestic violence and sexual offences against women & children etc.

It is also hereby informed that, a mechanism in the Core version of CIS is being worked out for such cases so that only the case number and its status will be made available on the internet to avoid any embarrassment to any of the parties.
