1. **QUALIFICATION**

For Peon:-

Standard examination and possess knowledge of Hindi/Punjabl. The applicant should fulfill the condition of qualification on the last date of receipt

of application.

For Sweeper:-

Candidate Should have experience of the duties required to be performed by him/her. However, he/she should be able to sign in Hindi or Gurumukhi

language as the case may be.

2. Age Limit:

No person shall be recruited to the service if he/she is less than 18 years or is more than 42 years of age as on 01.01.2024. However, age relaxation for reserved posts shall be applicable as per Reservation Policies framed by Government of Haryana from time to time.
