NOTE:-

- i) During the above spell, the Duty Magistrates/Civil Judges shall entertain and deal with the remand work, bail applications, Civil Suits of urgent nature along with applications for injunction made therein and other matters of urgent nature.
- ii) In case of any emergency, if duty Magistrate at headquarter Jind has to proceed on leave during this period, he/she shall make an alternative arrangement for duty work in his/her absence and shall obtain the consent of the Officer in writing, under intimation to this office.

- iii) In case of any emergency, if duty Magistrate at Sub Divisions, Narwana and Safidon has to proceed on leave, duty work of Sub Division Narwana will be entertained by the senior most Magistrate on duty at Headquarter, Jind and duty work of Sub Division Safidon will be entertained by the Junior Most Magistrate on duty at Headquarter, Jind.
- iv) Any Civil or Criminal matter of urgent nature instituted during this period if not disposed of during this period shall be put up before the Civil Judge(Sr.Divn)/Chief Judicial Magistrate, Jind/Addl. Civil Judge (Sr. Divn)/Sub Divisional Judicial Magistrate Narwana and Safidon as the case may be on 02.01.2025 for proper assignment
- v) Protocol duty, if any, shall be performed by the Senior Most Magistrate on duty at Headquarter, Jind.
- vi) Chief Judicial Magistrate, Jind is directed to prepare the Duty Roster for the month of January, 2025 w.e.f. 01.01.2025
