REASON:- Filling up the vacancy in the cadre of Junior Clerk-Cum-Copyist created due to non joining of Sri Satyabrata Naik appointed vide this office Order No.09 dated.28.02.2024 during the Recruitment Year 2023-24 pursuant to the Advertisement No.01, dated-31.07.2023.

ORDER

Due to non joining of Sri Satyabrata Naik as per this office Order No.09 dtd.28.02.2024 communicated vide Memo No.1308(30) dated.28.02.2024, **Sri Prabhudatta Prasad Behera, S/o- Indramani Behera, At/P.O/P.S-Chhendipada, Officer Pada, Dist-Angul presently at -Tapaswini Colony, Kanyabeda, P.S-Nalconagar, Dist-Angul, Pin-759145** appointed as Jr. Clerk-Cum-Copyist temporarily in the Pay Matrix Level-04 (ORSP Rules, 2017) Rs.19,900/- 63,200/- with DA and other allowances as admissible to the State Government Employees from time to time on regular basis subject to the result of W.P(C) No.1273 of 2014 and W.P.(C) No. 22278 of 2017 as per the merit list under SC category for the said post in accordance with the provision contained in *Odisha District & Civil Courts' Judicial Staff Services (Method of Recruitment & Condition of Service) Rules 2008* with following terms and conditions:

Terms & Conditions:

1. Your appointment is purely temporary and can be terminated at any time without assigning any reason/ cause thereof as per Rule 8(2) & (3) of *Odisha District & Civil Courts' Judicial Staff Services (Method of Recruitment & Condition of Service) Rules 2008*.
2. You are to remain on probation for a period of two years from the date of your joining in service, provided that if during the period of probation, your work or conduct is found unsatisfactory or it appears that you are likely to become inefficient, the District Judge may either discharge you from service or extend the period of probation for such further period as deems fit as per Rule 8(1) of *Odisha District & Civil Courts' Judicial Staff Services (Method of Recruitment & Condition of Service) Rules 2008*.
3. No TA shall be allowed for joining in the post.

4. Your appointment shall be cancelled if you fail to report joining at your place of posting on the scheduled date and time with relevant documents/ testimonials as mentioned below.
5. You are directed to report your joining in the Court of the **A.S.J-cum-Civil Judge Senior Division(Women's Court), Angul in the forenoon of 18.03.2024 positively** along with the following documents;
 - a. Original Educational Qualification Certificates for verification.
 - b. Medical fitness Certificate from a registered Medical Practitioner not below the rank of an Assistant Surgeon of Government Hospital in the prescribed form.
 - c. Two character Certificate from two different Gazetted Officers.
 - d. A declaration to the effect that he has not more than one spouse living, if married.
 - e. An undertaking in shape of an Affidavit that the financial benefit availed on regular basis shall be realized as per the applicability of the result of WPC No. 1273 of 2014 and continuity of service subject to the result of Writ Petition in WPC No.22278 of 2017 (Sumarendra Debata and Others Vs. Government of Odisha and Others).


