

The selected candidates shall be empanelled for translating reportable Supreme Court and High Court Judgments. The empanelled candidates shall be paid **remuneration of Rs 200/- per page of the Judgment assigned for translation** (including cost of typing and print-out).

**Terms and Conditions for translation work**

- The candidates duly selected in the panel for translation work shall follow the Standard Operating Procedure for translation work approved by the High Court of C.G.
- The remuneration shall be paid only after verification of translation work to the satisfaction of the concerned Authority.
- Remuneration shall be paid only to the Bank Account of the empanelled candidate.

**Procedure for Application**


