- 2. Application U/s 163A/164, 166 & 140 of Motor Vehicle Act arising out of the same accident for which already cases are pending in tribunal within the jurisdiction of the Civil District, shall be filed before same tribunal.
- 3. In absence of Special Judge (N.D.P.S./P.C. Act) his/her work will be looked after by Sessions

Judge, Mahasamund and in his/her absence senior most ASJ available in the District/Sessions division.

4. In absence of DJ/SJ, urgent work of his/her court will be heard and decided by the I<sup>st</sup> ADJ/ASJ In absence of I<sup>st</sup> ADJ/ASJ, Mahasamund, urgent pending work of his/her court will be heard and decided by next in nomenclature e.g. in absence of I<sup>st</sup> ADJ/ASJ, II<sup>nd</sup> ADJ/ASJ, ADJ/ASJ(FTC) etc. Subsequent bail petitions of co accused or same accused will place before the same judge who had earlier heard and decided the same, formal order of transfer of subsequent second bail petition is not required, application will be deemed transfered in said court.

In the absence of Special Judge (SC/ST) his/her work will be looked after by I<sup>st</sup> ADJ/ASJ, Mahasamund and in his/her absence senior most ASJ available in the District/Sessions division or in the absence of all of them by the Chief Judicial Magistrate of the District.

- 5. In absence of Sessions Judge bail applications related to sexual offences against women will be heard and decided by the ASJ(FTC) Mahasamund, formal order of transfer of bail petitions will not be required, applications will be deemed transferred in said court.
- 6. All works for which no provisions is made in this memo shall be presented before District &Sessions Judge, Mahasamund for proper order.
- 7. In Case of non availability of any judge, on account of leave or transfer or otherwise, urgent and important work of his/her Court shall be dealt with/heard by the available judge as per the following table, namely:-
