The Chief Legal Aid Defense Counsel will be given the liberty to engage law students as interns, to give them exposure to practical aspects of criminal law including preparation of defense strategy and doing legal research in various factual scenarios.

SLSA under the aegis of NALSA (www.nalsa.gov.in) is in process of implementation of LADCS at DLSA Chamba.

Applications are invited from eligible lawyers having requisite qualifications for Contractual full time engagement for the posts of **Deputy Chief Legal Aid Defense Counsel** and **Assistant Legal Aid Defense Counsels** as per scheme in district proposed herein.
