Sealed Quotation/ Tenders are invited from interested Service Provider/ Travel Agencies/ Tour Operators/ Private Individuals for providing 1(One) No. of AC vehicle (Petrol/ Diesel) like Tiago/ Bolt/ Celerio driven vehicles having sitting capacity not more than 05 (Five) including driver which shall confirm to the terms & conditions at (Annexure-A) for official use in Office of the District Legal Services Authority, Deogarh, on monthly rental basis as per the Govt. of Odisha Finance Department Notification No.22924/F, dt.14.08.2023.

- 01. The Service Provider shall have a valid OGST registration to participate in the tendering.
- 02. The Service Provider, participating in the bidding process under the jurisdiction of Municipal Corporation, shall be registered on GeM platform.
- 03. The vehicle must be in road worthy condition, shall not be more than 3 (three) years old from the date of initial registration and must have a valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc., mandatory for plying of vehicle.
- 04. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/ passenger vehicle.
- 05. The Driver should be well behaved, gentle and obedient in nature.
- 06. A sum of Rs.10,000/- (Rupees Ten Thousand) only shall be deposited by intending bidders in shape of Account Payee Bank Draft drawn in favour of the Secretary, DLSA, Deogarh and submit along with the tender as Security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 07. The monthly rate of hire charges be quoted separately in general bid information (excluding fuel and lubricants).
- 08. The vehicle must achieve a fuel efficiency of 17 K.M. per litre.

- 09. The details of the make and year of the manufacture of the vehicle, registration number, mileage (KM covered per litre) and name of the Driver, Driving License No. and period of validity should be specifically provided in general bid information to be furnished with the Quotation/ Tender (Annexure-B).
- 10. The Quotation completed in all respect should reach the undersigned vide address the Secretary, District Legal Services Authority, Deogarh, At- Ground Floor, District Court Complex, Deogarh, PIN-768119 through registered Post/ Speed Post/ By Hand on or before 25.09.2024 by 1 P.M. and shall be opened on the same day at 4.00 P.M. in the presence of bidders or their authorized representatives by the Selection Committee in the Chamber of Chief Judicial Magistrate, District Court, Deogarh. The bidders/quotationers should mention "Quotations for Providing Vehicle on Hire Basis" above the sealed envelope.
- 11. The Application Form of quotation/tender containing General Bid Information & Terms and Conditions for Hiring of Vehicles etc. will be available with the office of the District Legal Services Authority, Deogarh on payment of Rs.1,000/- (Rupees One Thousand) Only from 10 A.M. to 4 P.M. on every working days from dtd.06.09.2024 to 25.09.2024 towards tender paper cost or can be downloaded from website of District Court, Deogarh i.e. <a href="https://deogarh.dcourts.gov.in">https://deogarh.dcourts.gov.in</a> from dtd.06.09.2024 to 25.09.2024 up to 10 A.M. #### **TERMS & CONDITIONS**

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- 01. The hired vehicle, during the period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, Insurance Certificate, Pollution Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. and D.L. of the driver available all the times.
- 02. The District Legal Services Authority, Deogarh shall not be responsible for any damage/ loss caused to hired vehicle or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigations.
- 03. The hire charges to be paid for monthly basis is final, but does not include cost of fuel, which is to be paid separately basing on actual consumption and as per existing Govt. norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential coolant, Tyres & Tubes, Battery etc. will be borne by the bidder / Service Provider.
- 04. It shall be the responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by the owner.
- 05. In case of breakdown for reasons whatsoever, the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
- 06. In case the vehicles do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.
- 07. The vehicle shall report for duty for minimum 25 days in a month.
- 08. In case of emergency, the driver will have to report, for duty as per the requirement. No. extra payment shall be demanded.
- 09. Monthly hire charges and reimbursements towards cost of fuel (as per actual) and lubricants (as per govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
- 10. The vehicle shall not be more than 3 years old from the initial registration and also in good condition during the period of contract.
- 11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
- 12. In case the Service Provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

13. If the bidder violates any of the terms of the contract, the District Legal Services Authority, Deogarh shall forfeit the entire amount of security deposit.
