- vi.* All the original testimonials & the photo copies thereof which were submitted along with the Application Form (Testimonial in respect of Education, Caste etc.)
- vii.* One original valid proof of identification i.e. Aadhaar Card/ Voter ID card/ PAN Card/DL (for verification only).
