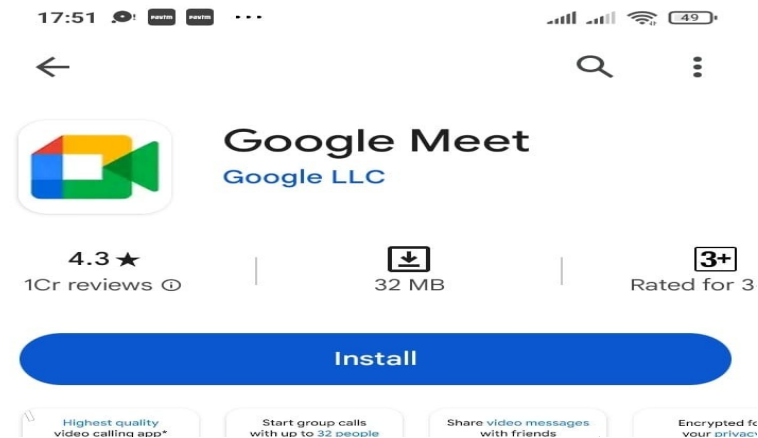


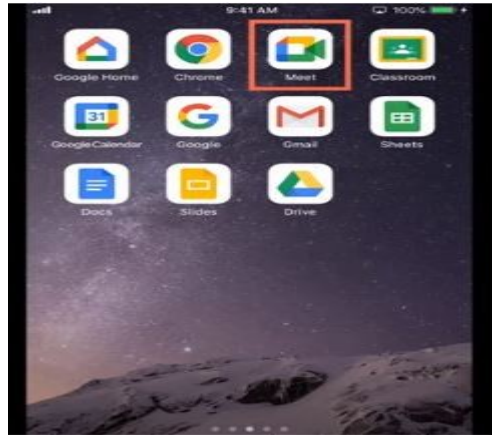

STEPS TO CONNECT THROUGH ZOOM LINK

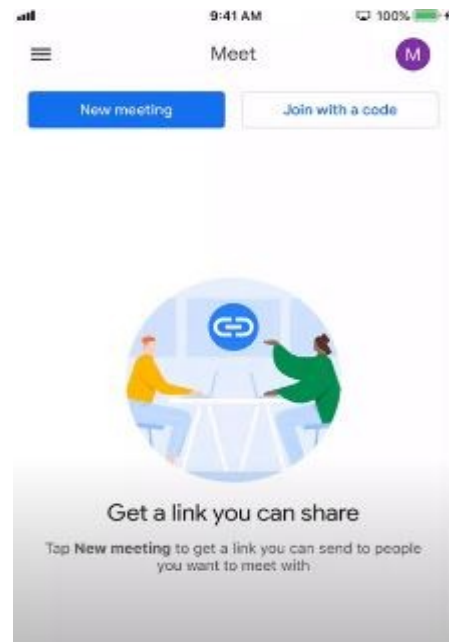
1. First of all install Google meet app from Play Store on your mobile phone and follow the below steps in Google meet app before using:-



2. Below icon is being displayed on your mobile screen




3. Click on Google meet App to open the App and there after below screen will be dsplayed on the screen
