
According to the instructions issued by the Hon'ble High Court, Chandigarh, vide letter No. 31522 Gaz.II/(10) dated 19.9.1995 arrangements for entertaining urgent matters such as bail applications/ injunctions, stay matters during holidays spell of four or more holidays including Saturday and Sunday both in Sessions Courts as well as lower Courts are required to be made. Magistrate at Rupnagar. Similarly, in case any Judicial Officer on duty at Rupnagar, on emergency, is not in a position to perform his/her duty, the same shall be performed by the Duty Judicial Officer present at Sri Anandpur Sahib or Nangal, under intimation to the undersigned.
