## High Court Of Rajasthan Establishes VC Remote Point At Sawai Man Singh Hospital, Jaipur, For Recording Doctor's Evidence



VC Remote Point at SMS Hospital Jaipur was e-inaugurated on 24.06.2022 by the Chief Justice of Rajasthan, Mr Justice S. S. Shinde. The Principal & Controller, SMS Medical College Jaipur Dr Sudhir Bhandari, and other doctors were present during the e-inauguration. The Hon'ble Chairman and Member of the Steering Committee were also present virtually. Rajasthan High Court has set up VC Remote Points in all 36 Court Complexes at the District Headquarters of the State. Taking this one step forward, the VC

Room at SMS Hospital Jaipur (The biggest Hospital in State) has been set up as VC Remote Point for the recording of evidence of doctors. This will enable the doctors working in SMS Hospital and other allied Hospitals in Jaipur to give their statements in cases through video conferencing. This will not only be facilitative to the witnesses, but timely testimony of witnesses will also help in the speedy trial of cases.

## Virtual Court For Traffic E-Challan Cases Launched by High Court Of Tripura



On 1st June 2022, The Virtual Court Web Portal developed by the e-Committee of the Hon'ble Supreme Court of India has been implemented in the State of Tripura to facilitate online payment of fines by the citizens in cases relating to challans arising out of Traffic violations in the area within the jurisdiction of the Superintendent of Police (Traffic), West Tripura District on a pilot basis. The Hon'ble High Court of Tripura

designated the Judicial Magistrate 1st Class, Court No. 1, Agartala, West Tripura as the "Virtual Court." The launch ceremony was organized at the Auditorium of the High Court of Tripura on 1st June 2022 at 10 am, and the project was launched by Hon'ble Mr. Justice Indrajit Mahanty, Chief Justice, High Court of Tripura in the presence of the Hon'ble Judges of the High Court of Tripura, the Chief Secretary, Transport Secretary, IT Secretary, Director General of Police, SIO of NIC Tripura, and other dignitaries/invitees from the Bar, the Bench, and the Media. A brief demonstration of the Virtual Court Project through PowerPoint presentation was given by the Central Project Coordinator of the High Court of Tripura during the programme.

## Rules For Live Streaming Of Court Proceedings Framed By High Court Of Chhattisgarh

<b>HIGH COURT OF CHHATTISGARH : BILASPUR</b>	
<b>NOTIFICATION</b>	
No. <u>5739</u> /Rules/2022	Bilaspur, dated <u>02/05/2022</u>
<p>With the objective of effectuating and broadening the implementation of Open Court concept during the virtual as well as physical hearings of the High Court and Sub-ordinate Courts, Tribunals and Authorities under the supervisory control of the High Court of Chhattisgarh, in exercise of powers conferred by Article 225 and Article 227 of the Constitution of India, the High Court of Chhattisgarh hereby makes the following rules as to the live streaming of Court proceedings of the High Court of Chhattisgarh, sub-ordinate Courts, Tribunals and Authorities under the supervisory control of the High Court of Chhattisgarh.</p>	
<b>1. Short Title &amp; Commencement:</b>	
(a) These rules shall be called the Chhattisgarh High Court (Live Streaming of Court Proceedings) Rules, 2022.	
(b) These rules shall be commenced w.e.f. 25/04/2022.	

“Chhattisgarh High Court (Live Streaming of Court Proceeding) Rules – 2022 ” was framed and notified by the High Court of Chhattisgarh, vide Notification No. 5739/Rules/2022, dated 02.05.2022. These rules commenced w.e.f. 25.04.2022. Live Streaming Rules have been uploaded on this High

Court's official website. These rules shall be applicable for conducting the court proceedings at the High Court and subordinate courts of Chhattisgarh.

## Chhattisgarh State Judicial Academy Conducts Training For New Potential Master Trainer Judicial Officers

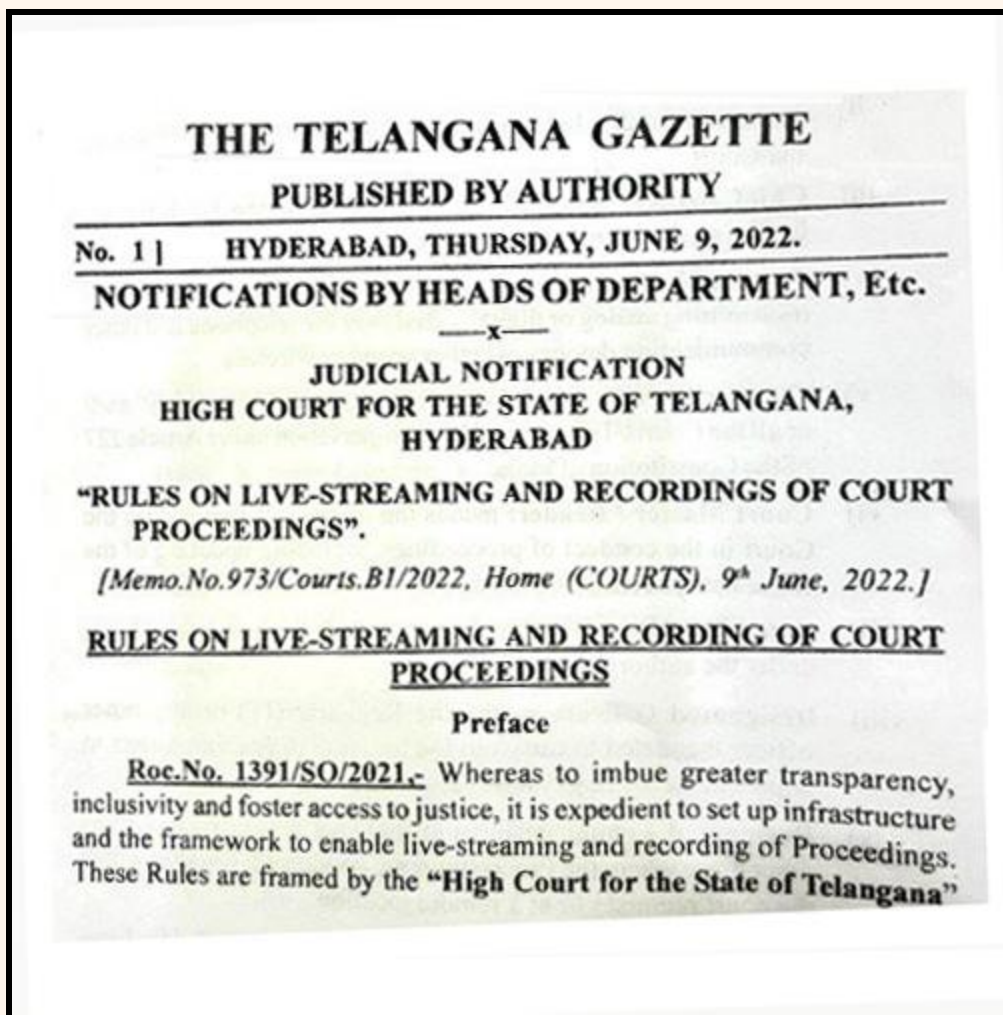

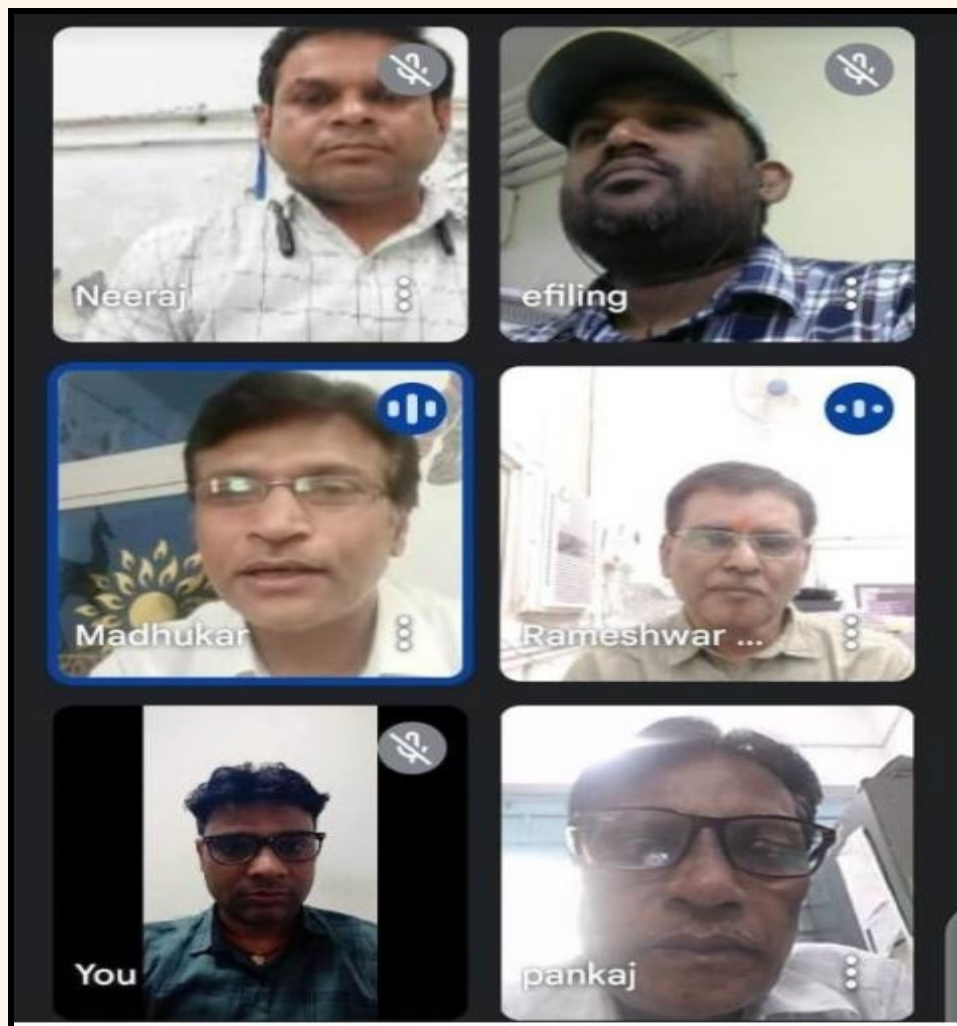
