RTI Act

The Right to Information Act (RTI) is an Act of the Parliament of India "to provide for setting out the practical regime of right to information for citizens" and replaces the erstwhile Freedom of information Act, 2002. The Act applies to all States and Union Territories of India except Jammu & Kashmir. Under the provisions of the Act, any citizen may request information from a "public authority" (a body of Government or "instrumentality of State") which is required to reply expeditiously or within thirty days.

The Act also requires every public authority to computerize their records for wide dissemination and to proactively certain categories of information so that the citizens need minimum recourse to request for information formally. This law was passed by Parliament on 15 June 2005 and came fully into force on 13 October 2005. Information disclosure in India was restricted by the Official Secrets Act 1923 and various other special laws, which the new RTI Act relaxes.

As per the direction of the Hon'ble High Court of Kerala a committee has been constituted with 8 members in the District Court, Palakkad with the District Judge as a chairman of the District Level monitoring committee, for the effective implementation and supervision of Proactive disclosure of information as mandated under section 4 of the RTI Act, 2005.

Hence the following directions are issued in this regard:

- 1. The Chairman of the District Level Monitoring Committee shall be the District Judge or a Senior Judge;
- 2. Pieces of information disclosed by the Subordinate Courts in the Website of the District Courts shall be as far as possible in accordance with the provisions/mandates in the Act maintaining uniformity in structure and content;
- 3. In addition to 16 manuals mandated in Section 4, information such as list of Courts in the Judicial District, details of Judicial Officers serving in the District and territorial jurisdiction of Courts shall be published;
- 4. Periodical inclusion/updation of information dsclosed shall be ensured/monitored by the District Level committees;
- 5. The District level committees shall comply with the above directions of this committee and submit reports by the end of November 2018.

According to the Hon'ble High Court of Kerala constituted a District Level Monitoring Committee to take necessary measures to ensure the information mandated under section 4(1) (b) of the RTI Act 2005. The constituted members are following below.
