ORDER No. 13/2023 DATED 25.05.2023

As per order of Hon'ble High Court of Karnataka notification vide read 1 and 2 and in exercise of the power conferred U/Sec 15(2) r/w Sec 410(1) of Cr.P.C., all the Criminal cases of Hanur and Ramapura Police Stations Jurisdiction are withdrawn from the court of Prl. Civil Judge and J.M.F.C., Kollegal and made over to the court of Addl. Civil Judge and J.M.F.C., Kolegala, for trial and disposal to the newly established itinerary court at Hanur, Chamarajanagar District.

All the cases of M.M.Hills Police Station related to the Hanur jurisdiction are withdrawn from the court of Senior Civil Judge and J.M.F.C., Kollegal and transferred to the court of Addl. Civil Judge and J.M.F.C., Kolegala, having jurisdiction of itinerary court at Hanur for trial and disposal in accordance with law.

Further new cases from M.M. Hills and Ramapura Police Stations jurisdiction have to be registered in the court of Addl. Civil Judge and JMFC Court Kollegala and all FIR's of these police stations have to be filed before the Addl. Civil Judge and J.M.F.C., Kolegala, having jurisdiction of itinerary court at Hanur.

Therefore, it is directed to the Police officers of concerned police station to submit all FIR's of the above said jurisdiction Courts with effect from 27.05.2023 to the court of Addl. Civil Judge and J.M.F.C., Kolegala, having jurisdiction of itinerary court at Hanur.

All PCR's cases of the above said jurisdiction have to be filed in the court of Addl. Civil Judge and J.M.F.C., Kolegala, having jurisdiction of itinerary court at Hanur.
