The number of posts in each cadre may increase or decrease. W stands for women and in the event of non-availability or availability of insufficient number of eligible women candidates belonging to any particular category, the vacancy or as the case may be, the remaining vacancies shall be filled up by male candidates of that category. Reservation in respect of Physically Handicapped persons/Ex-Service-men/Sports persons shall be as per rule.

2. Eligibilities of the candidates:

The Candidate:

a) Shall be a citizen of India and shall have passed at least +3 Examination or such other qualification equivalent to +3 Examination of a recognized university.

b) Shall have at least passed Diploma in Computer application from a recognized institute.

- c) Must be over 18 years and below 38 years of age as on 14.08.2028 (vide Govt. Of Odisha, G.A & P.G. Department, Notification No. 771/Gen, dtd: 11.01.2022) provided that the upper age limit in respect of reserved categories of candidates shall be relaxed in accordance with the provisions of the relevant act, rules, orders or instructions for the time being in force for the respective reserved categories.
- d) Shall be able to speak, read and write Odia and must have passed at least a test in Odia equivalent to the M.E. standard.
- e) Shall be of good character.
- f) Shall be of sound health, good physic and free from any organic or bodily infirmity.
- g) Must not have more than one spouse living, if married.
- h) Should not have any criminal proceedings pending against him/her.
- i) For the post of Junior Typist the candidate shall possess minimum speed of 40 words per minute in Typewriting in English language.
- j) For the post of Grade-III Stenographer the candidate shall possess minimum speed of 80 words in shorthand and 40 words in typewriting per minute.
- k) The Candidates who are already in Govt. employment shall submit his/her application through proper channel.
- I) Government Servant whether temporary or permanent are eligible to apply provided that they possess the requisite qualification and are within the prescribed age limit. They must inform their respective Heads of office in writing regarding submission of their application for this recruitment and obtain "No Objection Certificate".
- N:B:- (i) Application should be submitted for the post mentioning the name of post clearly (in capital letters with underline) on the top of the envelope.
- (ii) Non-compliance of any of the requirements mentioned in the notice shall entail rejection of his/her application. The application if found defective/incomplete in any respect and received after the last date, shall be summarily rejected.
