3. The Magistrate on duty shall also record the statement under section 183 BNSS,2023 of victims of rape cases, after court hours and on holidays.
4. The Magistrate on duty shall also perform the duty of protocol during his/her duty period under the supervision of undersigned/learned ACJM, Yamuna Nagar at Jagadhri.
5. The affidavits of the witnesses (deposing before learned Court of Sessions) pertaining to the sub division, Bilaspur shall be attested by the Duty Magistrate.

It is made clear that the affidavit of any person whose evidence is of formal character as provided in Section 332 BNSS,2023 be attested by respective Court/ Illaqa Magistrate.
