

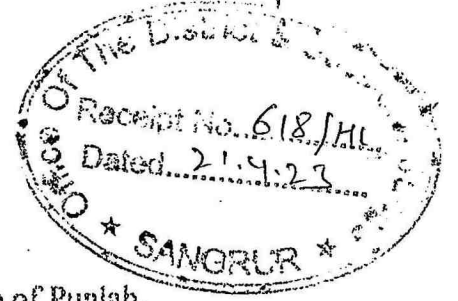

Sir,

Hon'ble the Chief Justice of India has approved the proposal for engaging three retired District Judges, on short-term contractual basis, as part-time Consultants, initially for a period of six months, to supervise and guide the team of law researchers for undertaking the exercise of physical verification of matters, grouping, tagging, classification, categorization of pending cases and preparation of briefs of the cases pending before this Hon'ble Court. The District Judges so engaged will be paid a consolidated monthly remuneration of Rs. 1,00,000/- per month.

I am, therefore, directed to request you to recommend names of retired District Judges, who are willing to take up the said assignment. Out of the names to be recommended, the suitable retired District Judges will be selected and offered appointment as part-time Consultant, on short-term contractual basis, initially for a period of six months, on a consolidated monthly remuneration of Rs. 1,00,000/-.
