TERMS AND CONDITIONS

APPENDIX-B

- 1. That the highest bidder shall be declared as successful contractor.
- 2. The District & Sessions Judge, Sangrur reserves right to reject the offer of any person/organizations/agencies without assigning any reason.
- 3. Every contractor aspiring to take part in auction shall have to deposit an amount of Rs.10,000/-, in the office of the Civil Judge(Sr.Divn.), Sangrur, as earnest money which shall be returned to unsuccessful bidders on the same day.
- 4. The contractor who has any outstanding dues towards this department shall not be allowed to participate in the auction.
- 5. The 25% of the auction price i.e. total auction price calculated for the period from 16.07.2024 to 31.03.2025, will have to be deposited at the spot by the highest bidder and if the contractor fails to do so his earnest money deposited by him shall be forfeited and the auction shall be held again.
- 6. The remaining amount shall be paid within the period mentioned in the form of agreement and if the contractor fails to do so, the earnest money/entire security deposited by him/her shall be forfeited. The successful bidder shall have to furnish his/her identity proof, resident proof as well as his/her two passport size photographs, in the office of the Civil Judge (Sr.Divn.), Sangrur, for record.
- 7. The concerned contractors will be responsible to maintain cleanliness in and around the canteen/shop as well as in parking area and will make own arrangements for disposal of the waste. The Committee concerned can inspect the canteen premises as well as parking area and in case of violation of rules, the Committee concerned, under approval of the District & Sessions Judge, Sangrur and the Hon'ble High Court of Punjab & Haryana, Chandigarh, shall have the right to cancel the contract and forfeit and entire security deposits.
- 8. The concerned contractors may operate the canteen during office working hours.
- 9. The contractors will not change the basic structure of the canteen and will not sublet the same.
- 10. Contractor will not sell any intoxicants in the canteen nor he/she will allow anybody to misuse the premises of the canteen. Narcotic/intoxicants or liquor service is strictly prohibited. There will be no smoking in the Canteen.
- 11. Canteen contractor should ensure proper quality of eatables and there will be quality checks from time to time and his/her contract shall be liable to be cancelled if he/she is found selling substandard products. The contractor will be liable under all laws particularly under the Prevention of Food Adulteration Act etc.
- 12. Contractor will be responsible for providing canteen service from 16.07.2024 to 31.03.2025. If he/she stop providing service mid-way then his amount shall stand forfeited and will not be refunded in any eventuality.
- 13. The contractor selected for canteen service will be required to maintain highest level of cleanliness both in and around the canteen premises and standard of hygiene with regard to the persons under his employment and utensils for serving the food. Big dustbin of good plastic should be kept. Carriers should be kept for disposal of wastage as per rules. Fly killer should be kept. Canteen should be cleaned daily. The items must be properly covered to maintain cleanliness.

- 14. The contractor shall not employ any person below the age of 14 years. No minor/bonded labour should be hired and the pay of employees will be given under the minimum wages Act.
- 15. The contractor will enter into the agreement as per prescribed proforma.
- 16. The canteen will remain closed on Sunday/Court holidays.
- 17. All the bylaws and M.C. Rules will remain in force.
- 18. Small stationary items may also be kept in the canteen.
- 19. Boards showing the rate list of items being sold in the canteen shall be displayed.
- 20. The packed food items will not be sold at a price more than MRP printed thereon.
- 21. In case of other items i.e. Self-made/prepared food items, the same shall not be sold beyond the market/D.C. Rates, keeping in view the weight and quality of the items.
- 22. The Committee concerned, under approval of the District & Sessions Judge, Sangrur and the Hon'ble High Court of Punjab & Haryana, Chandigarh, reserves the rights to alter or vary any term and condition regarding leasing out the Canteen, Computer shop at Judicial Courts Complex,_____
- 23. The contract shall be liable to pay any tax payable to Government on account of amount of auction.
- 24. The contract shall be liable to be cancelled at any moment if the contractor is found doing illegal activities or providing services which are not in concurrence with the above mentioned terms and conditions and the deposited amount shall be forfeited and will not be refunded in any eventuality.
- 25. Contractor will install his own electric connection and pay the bill to PSPCL or will install sub-meter without interference within the basic electricity configuration of the complex.
