- **I.** Applications in the prescribed format (vide Annexure-A) are invited from eligible candidates for engagement of persons on daily wages/purely temporary basis to meet the required services of Group-D employees in different courts of the Judgeship of Jajpur.
- 2. Number of persons to be engaged on daily wage basis:14 (Fourteen)
- 3. The last date and time for receipt of Application: 17.03.2025 at 05.00 PM.

 Applications received after the stipulated date and time shall be rejected summarily.
- 4. Date, Time and Place of Interview:-

The schedule of selection will be notified and intimated after scrutiny of the applications.

5. Terms and Conditions of appointment:-

The engagement of persons on daily wages/purely temporary basis on payment of minimum wages of unskilled work as would be revised from time to time by the Govt. of Odisha. He/she shall be liable to be disengaged at any time without notice. He/she will be posted in the headquarters station as well as outlying station of this judgeship depending on the requirement of different courts of this judgeship.

6. Remuneration/Wages:-

On payment of minimum wages of Rs. 452/- per day in accordance with the minimum wage for unskilled work, subject to revision from time to time as per government notifications.

7. Eligibility of the Candidates:-

In order to be eligible for being engaged on daily wage basis, a candidate

must:

- (i) be a citizen of India
- (ii) have passed M.E standard(Class-VII) examination conducted by any school or educational institution.

- (iii) be over18 years and below 32 years of age on the date of the advertisement.
- (iv) be of good character.
- (v) Be of sound health, good physique and free from organic defect.
- (vi) Not have more than one spouse living, if married.
- (vii) Not have any past criminal antecedent or record.

The candidates possessing special knowledge like gardening, cooking etc supported by valid certificate if any, would be preferred as against other candidates.

- 8. The candidates are required to submit the applications along with following documents:-
 - (i) Photocopy of self attested educational certificate.
 - (ii) Self attested voter ID card/ Aadhaar Card or any other identity card issued by the Government.
 - (iii) 4 Nos. of recent passport size colour photographs.
 - (iv) One self addressed envelope affixing postage stamp worth Rs.30/-(Thirty rupees).
 - (v) An undertaking renouncing any future claims for regular appointment.
 - (vi) An undertaking to the effect that there is no criminal antecedent against him/her.
 - (vii) Self-attested photocopies of relevant certificates possessing special knowledge like gardening, cooking etc, if applicable.
- 9. Incomplete or defective applications and applications received after due date and time shall be summarily rejected. No communication in this regard shall be entertained.
- 10. Envelope containing application must be inscribed "Application for engagement on daily wage basis."

- 11. No T.A/D.A will be paid to the candidates for attending the selection process. The decision of the District Judge, Jajpur as to result of selection shall be final and in no case shall liable to be challenged. Mere selection shall not confer any right uponthecandidates for engagement. The authority reserves the right to alter, modify or cancel the advertisement at any point of time without assigning any reason.
