ANNEXURE-A

- 1. That the highest bidder shall be declared as successful allottee.
- 2. The District and Sessions Judge, Ferozepur reserves right to reject the offer of any person/organizations/agencies/bank without assigning any reason.
- 3. The aspiring bidders/lessee bank shall move an application in this office on or before 13.09.2023 to the effect that they are willing to participate in the auction process.
- 4. The successful bidder/lessee bank shall deposit 25% of the lease money at the time of auction and the balance amount of 75% of the lease money shall be deposited within one month of the commencement of lease period and if the allottee fails to do so, the amount already deposited by him/her shall stand forfeited.
- 5. The concerned allottee will be responsible to maintain cleanliness in and around the Bank/ATM space and will make own arrangement for disposal of the waste. The office can inspect Bank/ATM space any time and in case of violation of rules the District and Sessions Judge Ferozepur shall have the right to cancel the contract and the forfeit the entire deposits.
