The Principal District Court, Nellore has issued the above three (3) notifications inviting applications in the prescribed proforma to the posts of Head Clerk, Personal Assistant, Junior Assistant, Typist and Attender <u>from the Retired Judicial Employees</u>, who have retired in the same category or above and also <u>from the eligible Outsiders</u> <u>directly</u> [in case of non availability of Retired Judicial Employees to the said posts] to fill up certain vacant posts in the Special Magistrate Courts of SPSR Nellore District on **contract basis.** Pursuant to the above three (3) notifications, applications are received by this Court from the retired Judicial Employees and also from the outsiders.

## In this regard,

- (i) All the applicants who are not retired employees of the Judicial Department applied to the post of Head Clerk in the Special Magistrate Courts pursuant to the above notifications are ineligible, since it is already mentioned in the notifications that the post is for retired Judicial Employees only and the eligible retired Judicial Employees who applied to the post of Head Clerk are directed to attend before the Principal District Judge, Nellore at 10:30 A.M on 26.8.2023.
- (ii) All the applicants who applied to the post of Attender in the Special Magistrate Courts pursuant to the notifications issued in the references 1<sup>st</sup> and 2<sup>nd</sup> cited are directed to attend before the Principal District Judge, Nellore at 10:30 A.M on 26.8.2023 excluding the applicants who passed SSC and above qualification, since they are ineligible for the post of attender.

(iii) All the applicants who applied to the post of Attender in the Special Magistrate Courts pursuant to the notification issued in the reference 7<sup>th</sup> cited are directed to attend before the Principal District Judge, Nellore at 10:30 A.M on 26.8.2023 excluding the applicants who passed Intermediate and above qualification, since they are ineligible for the post of attender.

(iv) All the applicants who applied to the posts of Personal Assistant, Junior Assistant and Typist in the Special Magistrate Courts pursuant to the above notifications are directed to appear for screening test on 23.8.2023 at 5:00 P.M in the Court Hall of Principal District Judge, Nellore and skill test will be followed for the posts of Personal Assistant and Typist. The applicants for the posts of Personal Assistant and Typist are directed to bring their type machines for the skill test. The candidates who qualify in screening test as well as in skill test [only for the post of Personal Assistant and Typist] will be called for interview in the ratio of 1:3.

The screening test is for 20 Marks out of which 10 Marks is for General Knowledge, 5 Marks is for English Grammar and 5 Marks is for Quantitative Aptitude.

This skill test is for 20 Marks and Interview is for 10 Marks.
